3D Imaging: The process of capturing the shape and appearance of real objects. The data can then be used to construct digital three-dimensional models.

(A)

Accountant: Analyze financial information and prepare financial reports to determine or maintain record of assets, liabilities, profit and loss, or tax liability.

Acupuncture: The ancient practice of piercing parts of the body with needles to treat disease or to relieve pain.

Addictions Recovery: Assist individuals and families in the recovery from drug and alcohol addiction.

Advertising: Sell advertising, including advertising space in publications. Persuade retailers to use sales promotion.

Advertising Direct Mail: The delivery of advertising material to recipients of postal mail.

Advertising Directory: The marketing of products or services in a directory listing.

Advertising Magazine: The marketing of products or services in Magazines.

Advertising Newspaper: The marketing of products or services in Newspapers.

Advertising Radio: The marketing of products or services on the radio.

Advertising Specialties: Sell collateral materials, such as key chains, mouse pads and pens, or give-a ways, to create extra interest in the purchase of a product or service for a department, or an entire company.

Advertising TV: The marketing of products or services on TV.

Air Duct Cleaning: The professional cleaning of the ducts used in heating, ventilation and air conditioning that deliver and remove air.

Air Purification: Sell systems for the purpose of filtering out impurities or treating air in households.

Alternative Energy: An energy source derived from non-traditional sources.

Answering Service: Provide service to answer business calls and take messages.

Antique Dealer: Sells and buys collected or desirable items because of its age, beauty, rarity, condition, utility, personal emotional connection and/or features. Can be vintage or new. **App Developer:** A person who develops specialized software applications for businesses,

networking and social databases.

Appliance Sales Repair: Sell, repair, adjust or install all types of electrical or gas household appliances.

Appraiser: Appraise personal property to determine its value for purchase, sale, investment, or loan purposes. (Does not include real estate).

Aquariums and Ponds: Someone that sells, stocks, services and maintains fresh and salt water glass aquariums (fish tanks in offices, hotels, restaurants and homes, as well as back yard ponds or ornamental pools for koi).

Arborist: A professional in the practice of the management and maintenance of trees. **Architect:** Plan and design structures such as private residences, office buildings, and other structural property.

Art Gallery: A public space for the exhibition of visual art for sale.

Art Reproduction (Canada Only): Using a picture, graphic, illustration etc. reproduces the image uniquely in any size, on any surface- paper, metal, glass, plastic, wood etc. **Artist:** Create original artwork using a wide variety of mediums and techniques, such as painting and sculpture.

Arts and Crafts: Online business that sells memberships for monthly shipments of clay materials, tools, and accessories along with online videos showing how to create and mold the clay.

Assisted Living: Assistance with activities of daily living; coordination of services by outside health care providers; and monitoring of resident activities to help ensure their health, safety, and well-being.

ATM Service Provider: Provides sales, leasing and placement of ATM machines, including transaction processing (processes the fees for the owner of the machine), repair, installation and ATM Monitoring.

Attorney Animal Law: Represent clients in any type of legal action, whether it be transactional or litigation, that effects the rights, standing and/or welfare of an animal. **Attorney Bankruptcy**: Represent clients in bankruptcy proceedings, including adversary proceedings.

Attorney Business: Represent clients in business litigation and transactional terms. Draw up legal documents including contracts, business formation and dissolution. Advise clients on buy/sell agreements.

Attorney Civil Litigation: Represents clients in civil litigation cases, except family, personal injury, and workers compensation.

Attorney Consumer Law: Negotiate to protect consumer rights against unfair practices from creditors as well as negotiate all types of debt so that we can provide an alternative to bankruptcy for consumers.

Attorney Corporate Law: Represents clients with the entirety of a corporation's activities from settling tax, employment, or labor problems, to setting up mergers between and among corporations and arranging stock options.

Attorney Criminal Law: Represent clients in criminal law cases.

Attorney Divorce: Represents clients in actions for divorce or annulment.

Attorney Elder Law: Represents clients in the issues faced by older individuals including, but not limited to, wills and trusts, health care, nursing home abuse, social security, retirement. **Attorney Ethics:** Represent clients to define how individuals, professionals, and corporations choose to interact with one another. Control, regulate, and legislate ethical conduct at the individual, corporate, and government levels.

Attorney Family Law: Represent clients in the area of the law that deals with family-related issues and domestic relations including, but not limited to: marriage, divorce, adoption, property settlements and alimony.

Attorney Franchise: Represent clients in the business method that involves the licensing of trademarks and methods of doing business.

Attorney Immigration: Represent companies or individuals undergoing the U.S. Immigration process.

Attorney Intellectual Properties: An attorney who practices in the areas of trademark, copyright, and/or trade secret law.

Attorney Labor and Employment: Represent clients in the body of laws, administrative rulings, and precedents, which address the legal rights of, and restrictions on, working people and their organizations.

Attorney Litigation (Grandfathered members only): Represent clients in the conduct of a lawsuit, civil action brought before a court in which a party seeks a legal or equitable remedy. **Attorney Malpractice:** Represent clients in an issue in which a professional, under a duty to act, fails to follow generally accepted professional standards, and that breach of duty is the proximate cause of injury to a plaintiff who suffers damages.

Attorney Municipal Court: Represent clients in a matter before a state court. **Attorney Patent:** Represent clients in patent cases to promote the publication of useful ideas.

Attorney Personal Injury: Represent individuals who are injured in a public or private place. **Attorney Real Estate:** Represent clients in litigation surrounding real estate transactions, nondisclosure or fraudulent transactions. Draw up legal documentation on transaction or purchase agreements.

Attorney Taxation: Represent clients in cases regarding tax laws.

Attorney Wills Trusts and Estates: Represent clients in the overall planning of a person's wealth, including the preparation of a will and the planning of taxes after the individual's death. Counsel clients on estate planning matters.

Attorney Workers Compensation: Help workers who are injured on the job recover compensation for their injuries, including medical bills and lost wages.

Auctioneer: Conduct auction sales.

Audio Video Systems: Sell, lease and install audio and video systems.

Audiology: Assess persons with hearing and related disorders. Fit hearing aids and provide auditory training.

Autism Services: Provide assistance to individuals with the brain development disorder of autism, which is characterized by impaired social interaction and communication, and restricted and repetitive behavior.

Auto and Tire Services: Provide routine service on motor vehicles and the tires of such vehicles.

Auto and Truck Repair: Diagnose, adjust, repair, or overhaul automotive vehicles.

Auto and Truck Wash: Own and operate a facility used to clean the exterior and, in some case, the interior of motor vehicles.

Auto Body Paint: Provide the service of painting the exterior of a motor vehicle.

Auto Body Repair: Repair auto bodies. Straighten vehicle frames.

Auto Broker: Buy and sell automobiles independently; not tied to any particular dealership, manufacturer, or financial institution.

Auto Bumper Repair: Repair the bumpers of automobiles.

Auto Detailer: Perform heavy duty cleaning of auto interiors and exteriors.

Auto Fuel Efficiency: Gasoline fuel additive to increase your mileage/horsepower which can prolong engine life & reduce maintenance costs.

Auto Glass Windshield Repair: Replace or repair broken windshields and window glass in motor vehicles.

Auto Lube Oil: Change oil and lubricate auto joints routinely.

Auto Parts: Sell or distribute auto parts.

Auto Rental: Provide rental vehicles to clients.

Auto Sales and Leasing: Sell or lease automobiles.

Auto Stereo and Accessories: Sell and install auto stereo systems. Sell accessories for automobiles, such as floor mats, seat covers, etc.

Auto Tire Sales: Sell tires for automobiles.

Awnings and Canopies: Manufactured for businesses, homes, boats, RV's and anything that needs temporary or permanent coverage including retractable awnings.

(B)

Bail Bonds: A bail bond agent, or bondsman, is any person or corporation, which will act as a surety and pledge money or property as bail for the appearance of a criminal defendant in court.

Bakery: Own or manage a bakery.

Balloons: Sell and design balloon bouquets.

Bankcard Services: Provide services and equipment to companies for the processing of major debit and credit cards.

Banker: Develop new customers for personal and business checking and savings accounts. **Banquet Facility:** Provide a venue where meals are served on-site for large and small groups. **Barber:** Someone whose occupation is to cut any type of hair, give shaves, and trim beards of men.

Bath and Body: Sell personal hygiene products.

BBQ Grill Maintenance: Professionals that clean barbeque units, maintain barbeques for cleanliness and safety.

Bed and Breakfast: Own or manage a bed and breakfast.

Bereavement Service: Provide assistance with the details of bereavement services operators, detailed cremation and burial site information or people working in the industry. **Beverage Sales:** The sale of beverages.

Bio-Energetic Medicine: An alternative medical system which uses energetic frequencies for the diagnosis, prevention and treatment of disease, such as pulsed electro-magnetic field therapy.

Bio-Hazard Hazmat Disposal: The cleanup and disposal of hazardous and waste materials. **Boat Rental:** A location that allows you use of a boat in their fleet without actually taking ownership of the boat. The user normally pays for the gasoline that they use, plus the cost of the rental.

Bookkeeper: One who records the financial transactions undertaken by an individual or organization; keeping records of what is bought, sold, owed, and owned; what money comes in, what goes out, and what is left.

Bookkeeping Systems: Provide systems/programs used to compute, classify and record numerical data to keep financial records complete.

Bottled Water: Sell bottled water for commercial or residential use.

Brewery: A building or establishment for brewing beer or other malt liquors, especially the building where the brewing is done.

Bowling Center: Own or manage a facility at which the sport of bowling is played.

Bridal Shop: Own or manage a facility at which bridal wear and accessories are sold. **Building Designer:** Refers to the broadly based technical application for the design of smaller, less complicated projects, usually coordinated with an architect or engineer.

Building Inspector: Formally inspect buildings for building code compliance purposes.

Building Permits Services: Assist in the process of gaining the necessary permits to build, renovate or add-on to an existing structure.

Building Supplies: Sell supplies to contractors used for building purposes.

Business Accreditation Services: Business/organization that assists people to be confident about the businesses they use by keeping records about how a business treats their customers.

Business Advisor: Provide advice to clients about business endeavors.

Business Broker: Perform transactions resulting in the purchase or sale of a business. **Business Consultant**: Give professional advice and helps develop a business plan for success. **Business Finance**: Area of finance dealing with the financial decisions corporations make and the tools and analysis used to make these decisions.

Business Forms Systems: Sell business forms for billing and receiving purposes.

Business Loss Prevention: Assist in fraud examination and loss prevention through forensic behavior analysis interviewing, risk assessments, risk analysis and loss prevention.

Business Valuation: A process and a set of procedures used to estimate the economic value of an owner's interest in a business. Financial market participants to determine the price they are willing to pay or receive to consummate a sale of a business use valuation.

C.A. (Canada Only): Chartered Accountant is a qualified accountant who is a member of Canadian Institute of Chartered Accountants who work in all fields of business and finance. **C.P.A. (Certified Public Accountant):** A qualified accountant who has certain examinations and met all other statutory and licensing requirements of a United States state to be certified by that state; "in addition to accounting and auditing, CPAs also prepare tax returns for individuals and corporations".

Cabinets: Construct, install or repair cabinetry.

Cable Services: Offers digital Cable TV, High Speed Internet and digital home phone services. Also provides assistance to existing and prospective clientele on billing and/or service related questions.

Calligraphy: The art of giving form to signs in an expressive, harmonious and skillful manner. A style of writing described as script, hand or alphabet.

Candle Consultant: Sell candles and home accessories as an independent consultant. **Career Consultant**: Provide professional advice about career choices.

Carpet Cleaner: Operate or tend machines to wash or clean carpets.

Carpet Repair: Repairing defects in the carpet such as holes, tears, unsightly seams and the like.

Caterer: Provide food and service for parties, events and business meetings.

Certified Accessibility Specialist: offers a full range of accessibility compliance services to assist businesses, property owners and architects to comply with the Americans with Disabilities Act.

Certified (Clinical) Exercise Physiologist: A person who studies human physiology and function and how it directly correlates to the benefits of exercise.

CFO: Part-time and Interim consultant in the fields of operations, finance, accounting, etc. **Chamber of Commerce:** Non-profit community service organization for businesses and individuals.

Check Cashing Service: A small or large company (not a bank) that will cash one's check for a fee. That includes personal, government and payroll checks, but not 3rd party checks or checks over \$500. Money orders and Western Union services are usually offered too. **Chef:** A person who cooks professionally.

Child Development Center: An ongoing service providing care of a child by a person other then the child's legal guardians. Can take on a more formal structure, with education, child development, discipline and even preschool falling into the fold of services.

Chimney Sweep: Clean the soot from the inside of chimneys.

Chiropractor: Adjust spinal column and other articulations of human body to correct abnormalities. Believed to be caused by interference with the nervous system. Examine patient to determine the nature and extent of the disorder. Manipulate spine or other involved areas.

Cleaning Products: Sell cleaning products for residential use.

Clinical Social Worker: A degreed and licensed individual who will assess, treat, develop treatment plans, provide case management and/or rights advocacy to individuals. **Closet Organizers:** Design and sell custom closet systems.

Cloud & Managed Data Storage: traditional Managed Data hosting involves an environment where resources such as RAM, Disk Space and Bandwidth are fixed. Cloud Servers are flexible resources that can be upgraded and downgraded quickly allowing you to optimize resource utilization.

Club Ambassador: "Retired" club members.

Coach Business: Provide support and advice to an individual or group in order to help them recognize ways in which they can improve the effectiveness of their business.

Coach Business Personal: Provide support and advice to an individual or group in order to help them recognize ways in which they can improve the effectiveness of their business and/or personal life.

Coach Personal: Provide support and advice to an individual or group in order to help them recognize ways in which they can improve the effectiveness of their personal life.

Coffee and Vending: Sell and service coffee and vending machines.

Coins and Stamps: Sell coins and stamps of value due to age, condition, length of circulation or historical value.

Collection Service: Collect debt for businesses from customers with outstanding accounts. **College Funding:** An organization that provides support through scholarships and funds toward higher education.

Colonic Hydrotherapy: Alternative medical therapy to remove fecal waste and unidentified toxins from the colon and intestinal tract.

Color Consultant: Provide professional advice about architectural color.

Commercial Audits: Refund and management services. Identify, plan and conduct audits and investigations going back 5 years to recoup overcharges for utilities and services.

Commercial Cleaning Services: New category name replaced Janitorial Services Commercial. Perform cleaning services required for commercial properties.

Commercial Lending: Coordinate commercial loans for business or commercial real estate. **Commercial Truck Sales & Leasing:** Sell or lease commercial trucks.

Communications Coach: Aims to teach effective communication and public speaking skills. **Community Association Consultant:** A nongovernmental association of participating members of a community, such as a neighborhood, village, condominium, cooperative, or group of homeowners or property owners in a delineated geographic area, may also serve as a Social Club. Participation may be voluntary, require a specific residency, or require participation in an intentional community.

Community Outreach: Provide service to people in the community that are in need of help monetarily or spiritually.

Computer Consultant: Provide technical assistance, answer questions or resolve computer problems for computer systems users in person, via telephone, or from remote location.

Provide hardware & software assistance for printers, installation, word processing, electronic mail, and operating systems.

Computer Hardware Software: Install, configure and support the physical parts and/or programs of a computer for business or personal use.

Computer Networks: Install, configure and support an organization's local or wide area network, Internet system, or a segment of a network system.

Computer Printer Repair: Perform repairs to computer printers.

Computer Programmer: Write, test, debug, and maintain the detailed instructions that computers must follow to perform their functions. Also conceive, design, and test logical structures for solving problems by computer.

Computer Repair: Perform repairs to hardware and peripheral equipment, following design or installation specifications.

Computer Sales: Sell computers; their hardware, software and peripheral equipment.

Computer Training: Instruct users in the function and operations of computers and computer programs.

Concierge: Provide personal assistant services such as informational requests, setting dinner reservations, making telephone calls, researching travel arrangements and more.

Confectioner: Make or sell candies.

Contractor Asphalt: Contract to lay and repair asphalt.

Contractor Builder: Authorized to manage the total construction process of structures and supervise the work of both qualified and non-qualified trades.

Contractor Carpenter: Build and repair wooden structures.

Contractor Chimney: Build and repair chimneys.

Contractor Commercial Doors & Gate Access: Installation, service and repair of commercial doors and automated access devices.

Contractor Concrete: Lay and repair concrete.

Contractor Concrete Sealer: Contract to have a coating applied to concrete to protect it from corrosion.

Contractor Decks: Build and repair decks.

Contractor Decorative: Supply or contract to install decorative accents and/or finishes to the interior of buildings.

Contractor Directory: Connects the buyers and sellers in the commercial building and construction industry. An online digital network that offers exposure to be found by Architects, Developers, Engineers, General Contractors, Subcontractors and Suppliers. **Contractor Drywall:** Install and repair drywall.

Contractor Electrical: Supplies electrical materials or personnel and to perform specialized construction work related to the design, installation, and maintenance of electrical systems. **Contractor Electronic Systems:** Supply and/or install electronic systems.

Contractor Fence: Contract to supply fencing material or to do fencing work.

Contractor Floor Covering: Contract to supply and install flooring material.

Contractor General: A project manager who organizes and oversees a construction project from start to finish. They complete the job by hiring different sub-trades to perform each step.

Contractor Grout Cleaner: A professional-grade cleaning process that leaves your grout surfaces sparkling clean. Removes the dirt and grime that builds up over time and restores the grout's color.

Contractor Hardwood Floors: Supply, build or repair hardwood flooring.

Contractor Home Performance: One who assesses through diagnostic testing and corrects the issues affecting comfort and energy usage in the home. Products and areas addressed

include HVAC (all heating and cooling), windows, insulation, air sealing (tightening the building envelope) and efficient lighting (BPI or RESNET accredited).

Contractor Insulation: Supply or contract to install insulation.

Contractor Landscape: Landscape construction, install block walls, and pave walkways and driveways.

Contractor Low Voltage: Install, service and maintain systems, which are energy, limited and do not exceed 91 volts.

Contractor Masonry: Lay and bind building materials such as brick and block with mortar and other substances to build walls and structures.

Contractor Mobility Products: Service and install mobility products such as stair lifts, vertical platforms lifts, modular ramps and car host for mobility products.

Contractor Painting: Supply painting materials and/or contract to do painting work.

Contractor Paving: Supply paving materials or contract to lay and repair pavement.

Contractor Plumbing: Contract to supply plumbing materials or to do plumbing work.

Contractor Pools: Contract to design, build or install swimming pools.

Contractor Remodeling: Contract to supply remodeling materials or to do remodeling work. **Contractor Roofing:** Contract to supply roofing material or roofing work.

Contractor Siding: Contract to supply exterior building siding material and/or install, repair siding.

Contractor Supplies: Provide the necessary supplies for construction and carpentry **Contractor Tile Granite Marble:** Installation of tile, marble and/or granite for home or business.

Contractor Tub and Tile Resurfacing: Resurface existing tubs and tiles for home or businesses.

Contractor Waterproofing: Contract to supply and/or install waterproofing water-resistant materials.

Contractor Wood Refinishing: Refinishing of any wood surface to a like new appearance. **Copiers Fax:** Sell or solicit copy and fax machines.

Copies: Sell copies of documents.

Copywriter: Professional writer responsible for content that promotes a person, business, opinion, or idea.

Corporate Communications: Provide communication, which goes to all staff; serve as the liaison between an organization and its public.

Corporate Events: Provide management and production for company parties, promotions and events.

Corporate Payment Programs: Help companies streamline payment processes, save money and generate additional revenue. Work with accounts payable departments to eliminate paper checks and increase operational efficiencies.

Cosmetic Laser: Create a treatment plan for aesthetic skin care including laser treatment. **Cosmetic Surgeon:** A surgeon who beautifies the body with the medical specialty interested in the correction of form and function.

Cost Consultant: Audit expenses for better pricing to increase revenue for companies. **Cost Segregation:** The process of identifying personal property assets that are grouped with real property assets and separating out personal assets for tax reporting purposes.

Counter Tops: Provide replacement and fabrication of counter tops for kitchens and baths. **Country Club:** Own or manage a country club.

Courier Service: Pick up and carry messages, documents, packages and other items between business offices.

Court Reporter: A person whose occupation is to transcribe spoken or recorded speech into written form, to produce official transcripts of court hearings, depositions and other official proceedings.

Courtroom Presenter: Someone who is responsible for Trial exhibit displays to a jury in a courtroom during a trial. This person does all technical set up and break down and all things related in between pertaining to the exhibits.

CPR Trainer: Train individuals to perform the emergency medical procedure for a victim of cardiac arrest or, in some circumstances, respiratory arrest.

Credit Restoration: Provide clients with ways to repair negative credit reports with an emphasis on credit education to prevent future issues.

Cryotherapy: Is the local or general use of low temperatures in medical therapy or the removal of heat from a body part. Its goal is to decrease inflammation, pain and spasms and promote healing. A non-medical procedure, but an option for people seeking faster muscle and joint recovery from injury and fatigue.

Cryptocurrency: Bitcoin, a new electronic cash system that uses a peer-to-peer network to prevent double-spending. It's completely decentralized with no server or central authority. **Culinary School:** a location designated to teaching the art of cooking to children as well as adults.

Custom Basement: Framing a basement for custom orders to include all issues of being below ground, such as mold, humidity, water and proper venting while holding all the necessary licenses specializing in subterranean living spaces.

Custom Clothing: Create and sell clothing made for a specific individual.

Custom Framing: Create and sell frames made for specific pieces of artwork or photography. **Cutlery:** Sell utensils, as knives, forks, and spoons, used at the table for serving and eating food.

Dance Instruction: Private or group lessons in the art of dance.

Data Backup and Recovery: Various strategies and procedures involved in protecting your database against data loss and reconstructing the database after any kind of data loss. **Dating Service:** Systematic means of improving matchmaking via rules or technology. A specialized meeting system where the objective of the meeting, be it live or phone or chat based, is to go on a live date with someone.

Day Spa: Center for relaxation, rejuvenation, exercise, and various treatments that does not require a client to stay overnight.

Debt Arbitrator: Third-party institutions that work on behalf of their clients to negotiate outof-court settlements for old bills, invoices, lawsuits, liens, medical bills, utility bills, judgments, and other types of significant debt.

Debt Consultant: Provide advice, information, and help to people who are in debit.

Decorative Painter: Artist utilizing a variety of techniques and media to decorate functional and non-functional surfaces.

Decorative Plumbing Supplies: Design and supply decorative fixtures for Kitchens and Bathrooms

Delicatessen: Shop that sells cooked or prepared foods ready for serving.

Demolition Hauling: Haul away the refuse from a construction project that occurred during demolishing.

Dental Hygienist: Specializes in preventive dental care, focusing on techniques in oral hygiene.

Dental Lab: manufacture or customize a variety of products to assist in the provision of oral health care by a licensed dentist. These products include crowns, bridges, dentures and other dental products.

Dentist: Diagnose and treat diseases, injuries, and malformations of teeth, gums, and related oral structures. Treat diseases of nerves, pulp, and other dental tissues affecting vitality of teeth.

Dermatologist: One that practices a branch of medicine dealing with the skin and its diseases, a unique specialty with both medical and surgical aspects. Taking care of diseases, in the widest sense, and some cosmetic problems of the skin, scalp, hair and nails.

Design Consultant: design, draw and complete building permit documents for you to remodel, an addition or new house.

Digital Story Booking: A way to preserve and share your written memories, photos and digital artwork to create your story in book form, greeting cards and other printed novelties. **Disc Jockey:** Select, and play recorded music at special events.

Divorce Financial Analyst: A Financial professional who is certified to help people navigate the specific money issues that come up during a divorce.

Document Imaging: Information technology for systems capable of replicating documents commonly used in business.

Document Shredding: Destroy documentation by way of shredding.

Dog Day Care: Location to drop off dogs to be cared for while the owner is at work. **Doula:** An assistant who provides various forms of non-medical and non-midwifery support

(physical and emotional) in the childbirth process.

Driver Instructor: Providing driver education for teens and adults.

Drone Services: Provides professional services using drones as well as selling, repairs and service provider of the drones.

Dry Cleaner: Provide service to wash or clean garments.

Dryer Vent Services: Provide service to clean the vents of residential dryers.

eCommerce: Assist clients with selling their items through online auctions and other shopping websites.

Education: Provide schooling.

Education Consultant: an independent person who helps parents and students with educational planning. Helps families develop a strategic plan to meet certain goals or resolve certain problems. Will not provide Financial Planning.

Education Theater: Provide and expose you to all aspects of theatre, music and dance. Workshops are taught by Board of Education Certified Theatre teachers and professional actors, singers and dancers, as well as workshops with professional casting directors and producers.

Elder Care: works with the elderly and their families to bridge the gap between health care providers and end users.

Elder Care Consultant: Help older adults and family members successfully manage the challenges of aging, disability, and dementia through private consultation, geriatric care management, and fiduciary services.

Electrician: An individual, licensed tradesman specializing in electrical wiring of buildings and related equipment.

Electronics Repairs: Provides repairs and service for all types of small electronic devices (eg. Cell phone, iPod, iPad, mp3 and video games).

Elevator Sales & Maintenance: Manufactures and maintains people-moving products, including elevators, escalators, and moving walkways.

Embroidery: Create and sell products with raised and ornamental designs in thread. **Employee Leasing:** Provides human resource tasks, and as "employer of record" handles payroll & benefits of employees.

Employment Screening: Provide employers with a background check of potential hires, including but not limited to, public records, commercial records and financial records.

Employment Service: Employment resource providing job-finding assistance to job seekers and employers for direct hire and temporary employees.

Energy Consultant: Evaluate your energy consumption, and provide a clean avenue for you to lower energy costs and save money.

Energy Therapist: A healing practice "that does not fall within the realm of conventional medicine, it is an alternative medicine that re-balances the body's energy field so that health can be restored.

Engineer: Degreed individual offering solutions to technical problems through scientific knowledge.

Engraving: Providing the incising of a design onto a hard, usually flat surface, by cutting grooves into it.

Enrolled Agent: A tax professional recognized by the United States federal government to represent taxpayers in dealings with the Internal Revenue Service.

Entertainment: Coordinate entertainment for special events.

Entertainment Party Rentals: Company, renting special event items and equipment.

Entertainment Race Car: Indoor radio control racetrack for children and adults.

Environmental Consultant: Give professional advice on environmental and conservation issues. **Environmental Oil Tank Service**: remediation for the removal of polluted or contaminated media. Provides location and installation of new tanks.

Equipment Sales & Leasing: sales and leases contractor and industrial equipment.

Escrow Agent: The neutral third party that holds an asset such as cash, real property or other tangible assets pending satisfaction of contractual contingency or condition.

Essential Oils: Health oils in aromatherapy and natural healing process. Both as topical and used in foods and cleansing products.

Estate Advisor: Advise an individual on the total of a person's property, entitlements and obligations.

Estate Sales: Type of sale to dispose of the majority of the materials owned by a person who is deceased or will be moving. Usually conducted by a professional, for a percentage of the revenues.

Esthetician: Provide preventative skin care and treatments to keep skin healthy and attractive.

Event Facility: Location for holding special occasions, such as weddings, parties and business functions.

Event Lighting: Designing, producing and installing lights from basic to an elaborate display including unique special effects lighting for special events, such as weddings, prom's, fund raisers, etc.

Event Planning: Coordinate and plan special occasions, such as weddings, parties and business functions.

Event Rentals: Rent out the equipment needed for special occasions such as weddings, parties and business functions.

Excavating: Make hollow by removing the inner part; make a hole or cavity in; form into a hollow, as by digging.

Executive Gifts: Sell gifts designed for recognition purposes.

Executive Offices: Provide professional office space for lease for full-time or virtual clients.

Factoring Broker: Lend money on, or buy and collect accounts receivable.

Family Counseling: Counsel and assist clients with personal, family, educational, mental health, and career issues.

Faux Painter: Decorative painting technique applied to walls and furniture.

Feng Shui Consultant: Helping individuals in the Chinese art or practice of creating harmonious surroundings that enhance the balance of yin and yang.

Fiduciary: A legal or ethical relationship of confidence or trust between two or more parties. Typically, a fiduciary prudently takes care of money for another person.

Financial Advisor: This person must hold a series 7 license. They handle stocks, bonds, and mutual funds.

Fingerprinting: Capture fingerprints and palm prints electronically or with the traditional method of ink and paper.

Fire Extinguisher Sales Service: Sell and service fire extinguishers.

Fire Protection: Sell and service fire protection equipment.

Firearm Instructor: A certified instructor that gives hands on training focused on the safe handling and storage of firearms.

Firearm Safety: Entertainment using high definition projection and infrared laser technology. **Fireplace Sales**: providing homeowners and builders with custom fireplace solutions and quality craftsmanship.

Fitness Center: Place which houses exercise equipment for the purpose of physical exercise. **Floor Covering:** Retail location that sells supplies for the covering of floors.

Floor Heating: Sell and install floor-heating systems.

Flooring Restoration: Restore and refinish hardwood floors.

Florist: Design, cut, and arrange live, dried, or artificial flowers and foliage.

Food Distributor: Market and distribute food and related products.

Food Menu Assembly: Create food for clients to assemble and take home for preparation. **Food Service Equipment:** A distributor that sells and services specialized commercial food holding equipment, including refrigerators, prep tables and custom mfg equipment, new and/or used.

Food Specialist: Create edible gifts for sale to customers.

Forensic Accountants: Experienced auditors, accountants and investigators of legal and financial documents that are hired to look into possible suspicions of fraudulent activity within a company; or are hired by a company who may just want to prevent fraudulent activities from occurring.

Foster Care: A 24-hour substitute care for children placed away from their parents or guardians and for whom the State agency has placement and care responsibilities. Foster parent must meet state-certified (where required) guidelines.

Franchise Consultant: A specialized category of professional assistance for investors, entrepreneurs, and enterprises.

Freight Services: Provide transport of goods, cargo, or lading.

Fuel Sales and Service: Sell fuel and service the equipment that generates the fuel.

Fund Raising: Raise funds by soliciting contributions or pledges.

Funeral Director: Director of funeral services.

Funeral Services: Provide services for a funeral.

Furniture: The assembly of furniture and/or other items that need to be put together.

Furniture Rental: A company that provides long or short-term rental of furniture for residential and commercial use.

Furniture Restoration: Restore and repair-damaged furniture.

Galvanic Skin Hair and Scalp Treatments: a device that delivers safe, effective galvanic (positive & negative) currents and uses specially formulated gels to get the treatment to the dermal layer.

Garage Doors: Sell and install residential or commercial garage doors.

Gift Baskets: Sell custom gift baskets.

Gift Catalog: Own and operate a catalog containing items for sale to the public.

Gift Shop: Own /manage a gift shop.

Glass: Sell glass.

Glazier: A professional, who selects, cuts, installs and replaces glass on both commercial and residential job sites.

Global Positioning System: Sell and install global positioning systems for vehicles. **Golf Cart Sales:** Sell golf carts.

Golf Instructor: The art of equipping and training golfers to play better golf through improved awareness of swing cause and effects as a result of the actions by their body, the club, and their effect on the golf ball.

Golf Pro: Someone that makes their living from teaching the game, running golf clubs and courses, and deals in golf equipment.

Graphic Design: Design or create graphics for commercial or promotional needs, such as ads, displays or logos.

Greeting Card Service: Provide customers with access to online greeting cards to send to recipients.

Gutters: Install and clean gutters.

Gym Equipment Service: Service and repair of fitness equipment.

(H)

Hair Stylist: Shampoo, cut, color, and style hair.

Handyman: Provide a variety of improvements, repairs and maintenance needs in and around the home.

Hardware (non-computer related): Sell supplies such as nails, tools, locks, hinges, and hammers.

Hauling Service: Provide the service of removing unwanted debris.

Health Advocate: Designated clinical consultant organizes a wide variety of health carerelated support and educational services for patients.

Health and Fitness: Health-related fitness involves exercise activities that you do in order to try to improve your physical health and stay healthy, particularly in the categories of cardiovascular endurance, muscular strength, flexibility, muscular endurance and body composition.

Health and Nutrition: Sell health and nutrition products. Must be practicing under the states laws or something that would show they need to be certified, licensed, whatever they need to be for that state. (This should be for a health food store, a naturopathic doctor selling stuff, a nutritionist or someone like that who is licensed, etc)

Health and Wellness: Provide health and wellness services. (This is for the Melalueca, shaklee, Amway, Arbonne, etc. It would also include the juice plus, the stuff that comes in a wine bottle, etc.)

Health Care Service: Provide the service of health care.

Health Spa: Facility devoted especially to health, fitness, ancient, traditional and modern therapies.

Hearing Aids: Sales of hearing aids.

Heating and Air Conditioning: Install, service, and repair heating and air conditioning systems in residences and commercial establishments.

Historical Collectibles: Deals in Historic Collectibles, Historic documents, rare books and manuscripts (written records of historic events and daily life from medieval times through modern times)

Hitches and Trailer Repairs: The installation of hitches/tow packages and trailer repairs **Holiday Lighting**: Provide and install lighting for special events such as Christmas, Halloween, Weddings, etc. Service and remove lighting when event is finished.

Holistic Health Care: Provides health care for the entire patient, in all aspects, often using many natural and alternative treatments.

Home and Property Inspector: Examine and inspect materials and construction to determine the condition of a structure, home or commercial building, and compliance with work orders in an unbiased, professional manner.

Home Automation: The automation of home audio, video, and lighting systems. **Home Décor:** Sell decoration for the home.

Home Entertainment: Sell custom home entertainment systems.

Home Health Care: Provide caregivers to meet the home care needs of the individuals.

Home Improvements: Renovating or making additions to a home. Projects that upgrade an existing home interior.

Home Inventory: Provide an inventory itemizing the values of your property and valuables in case of disaster or burglary.

Home Theater Sales: Sales of cinema-quality video and audio for the home.

Home Theater Specialist: Advice and repair of cinema-quality video and audio for the home. **Home Warranties:** Provide home service contracts.

Hormone Replacement: is any form of hormone therapy wherein the patient, in the course of medical treatment, receives hormones, either to supplement a lack of naturally occurring hormones, or to substitute other hormones for naturally occurring hormones.

Hospice Care: A type of care and a philosophy of care, which focuses on the palliation of a terminally ill patient's symptoms.

Hospital Care Consultant: Someone that will arrange, consult and advise as a third party on hospital patient's needs and care. Acting as a go between the physician, patient and family. **Hospitality Staff:** Provides all catering staff, such as waiters, bartenders, chefs, coat check attendants, porters and captains to serve you and your guests.

Hot Tubs: Sell and service large tubs that are filled with heated hot water.

Hotel & Restaurant Supplies: Sells supplies and equipment to hotels and restaurants. **Hotelier:** Manage or own a hotel, motel or inn.

Human Resources: Provides hiring, firing, training, and other personnel issues.

Hyperbaric Oxygen Therapy: (HBOT) is the medical use of oxygen at a level higher than atmospheric pressure.

Hypnotherapist: Provide physical and mental therapy to patients through the act of hypnosis.

Ice Cream Parlor: Restaurants that sell ice cream, gelato, sorbet and frozen yogurt to consumers.

Image Consultant: Someone that provides a customized service that plans, coordinates, and maintains your wardrobe so you are perfectly attired for any situation. Will also, assist you in selecting cloths and accessories that compliment you including using clothing from your closet.

Immigration Consultant: (Canada Only) fully authorized by the government of Canada to assist and represent people with respect to applications to Citizenship & Immigration Canada Departments (CIC); Canada Border Service Agency (CBSA) and the Immigration & Refugee Board of Canada (IRB).

Import Export: to bring in and ship (merchandise and commodities) from or to other countries or places for use, sale, exchange, processing, or to re-export.

Information Technology Consulting: Consult clients on the study, design, development, implementation, support or management of computer-based information systems, particularly software applications and computer hardware.

Ink and Toner: Sell the inkjet and laser toner cartridges used for computer printers. **Insurance Commercial:** Coverage for businesses for protection against potential losses through unforeseen circumstances like theft, liability, property damage, and for coverage in the event of an interruption of business or injured employees.

Insurance Employee Benefits: Various types of non-wage compensation provided to employees in addition to their normal wages or salaries.

Insurance Life Health and Disability: Sell life, health, and disability insurance, as well as nonsecurities annuity contracts that are allowed with a LHD License, all others fall under a Series 6 or 7 licenses.

Insurance Property and Casualty: Sell property and casualty insurance. (workers compensation).

Insurance Supplements: Sell additional insurance coverage that provides for items other insurance policies do not.

Interior Decorator: Practitioners who specialize in arranging interiors in various styles, working within the walls of a room.

Interior Design: Plan and design interiors of residential, commercial, or industrial buildings. **Interior Plantscape:** Plan and design layout of interior plants.

Internet Consultant: Assist and advise clients with navigating and applying Internet technology.

Internet Marketing: Advertising any kind of good or service to potential consumers via digital strategies.

Internet Web Design: Research, design, develop, test and host operations of websites for clients.

(J)

Janitorial Services Commercial: Perform cleaning services required for commercial properties. This category name is grandfathered and was replaced by Commercial Cleaning Services. Janitorial Services Residential: Perform cleaning services required for residential properties. This category name is grandfathered and was replaced by Residential Cleaning Services.

Janitorial Supplies: Sell products for commercial cleaning purposes.

Jeweler: Fabricate, sell and repair jewelry.

Jukebox Repair: Repair and restore antique and classic jukeboxes and radios.

Junk Removal: Remove unwanted debris, waste and materials from clients' properties or businesses.

(K)

Kitchen and Bath Design: Provide layout and design ideas for kitchen and bath remodeling. **Kitchen Products:** Sell products used in the home kitchen.

Knitting Clothing: Knitting supplies, accessories, classes and garments.

(L)

Landscape Architect: Planning and design of an exterior landscape or space by an accredited individual.

Landscape Artificial Grass: Sell artificial grass for exterior landscapes.

Landscape Design: Design of an exterior landscape or space.

Landscape Maintenance: Maintain an exterior landscape or space.

Landscape Waterfalls: Plan, design and install waterfalls for an exterior landscape or space.

Language Translator: Someone who provides translation services from a source language to a target language.

Laundromat: Own and operate a facility for washing and drying clothing.

Lawn Aeration: Controlling lawn thatch and reducing soil compaction.

Lawn and Yard Maintenance: Maintain client's lawn and yard.

Lawn Sprinklers: Provides the installation, repairing and servicing of all types of lawn sprinkler systems to water lawns, gardens or other plants.

Leather and Vinyl Repairs: Clean and repair leather and vinyl (eg. Furniture, boats, planes, autos, etc.) usually at a client's location.

Legal Document Preparation: Prepare legal documents for persons representing themselves or others in a legal matter.

Legal Nurse Consultant: Acts as a liaison with attorneys, physicians and clients.

Legal Process Server: A professional resource for lawyers and the public to serve process, including complaints, writs, summons, subpoenas and other legal documents.

Licensed Practical Nurse (LPN): A person who has graduated from an accredited school of nursing and has become licensed to provide basic nursing care under the supervision of a physician or registered nurse.

Lighting: Sell and install lighting.

Limousine Service: A longer then normal luxury car with a chauffeur to transport passengers. **Linen Rental Supply**: Rental of professionally cleaned cloth products and delivery to a client's location or pick up.

Litigation Support: Provide support for litigation with in depth research.

Live Scan Fingerprinting: Capture fingerprints and palm prints electronically, without the need for more traditional method of ink and paper.

Locksmith: Repair and open locks, make keys, change locks and safe combinations, install and repair safes.

Loyalty Program:

a program that rewards customers for making purchases from the same vendor or company. Loyalty programs may offer prizes, reward points, future discounts and other incentives

designed to keep customers coming back and doing repeat business with you.

Lubricant Manufacture & Sales: Creates lubricant products for the end users

Machinists: Use machine tools to make or modify parts.

Magician: A person that performs tricks of illusion and sleight of hand.

Mailing Equipment Sales: Sells "mail service" equipment to companies or individuals for direct mail, packages, and product wrapping also sells bar code skew labels.

Mailing Services: Provide outgoing and incoming mail and shipping services.

Make-Up Artist: Create make-up and prosthetics for a client's professional or personal use.

Make-Up Artist Permanent: Cosmetic technique which employs the permanent pigmentation of the dermis as a means of producing designs that resemble make-up.

Marine Services: Provide private cruise service.

Marketing: The advertising, distribution and selling of a product or service.

Marketing Consultant: Person who advises on the demand for products and services offered by a firm and its competitors and identify potential customers.

Marijuana Dispensary: Where legal by law, Retail sale of Marijuana for recreational and medical use

Martial Arts: Teaches the practice and traditions of training for fitness, self-defense, sport, and mental discipline, character.

Massage Therapist: Alleviate pain, relieve stress, and improve the health and well being of their clients by the manipulation of the soft tissue.

Mediator: A person who assists in negotiations and conflict resolution.

Medical Aesthetics: Create a treatment plan for a medical skin treatment.

Medical Billing: Process medical billing for medical offices.

Medical Equipment: Sell equipment and supplies for medical treatment.

Medical Imaging: Provide diagnostic imaging services to patients and their referring physicians.

Medical Practice Consultant: Typically advise physicians on the business issues they face in outpatient private practice.

Medical Spa: Facility for clients to receive medical treatment for a variety of cosmetic procedures.

Medical Transportation: Basic Life Support (BLS) emergency and non-emergency ambulance transportation.

Medicinal Cannabis: A compound derived from Hemp that has significant medical benefits. Reduces pain, anxiety, and inflammation.

Memorial Monuments: Selling of memorial headstones for gravesites, civil memorials and monuments, usually made from but not limited to marble, granite or bronze.

Mental Health Counselor: Licensed professional that provides services to help adults, couples, children, teens, and families work through personal issues, including but not limited to depression, anxiety, stress, parenting, self-image, relational and marital difficulties, grief and bereavement, and addiction.

Mergers & Acquisitions: Private advisory firm dealing with transactions in which the ownership of companies, other business organizations, or their operating units are transferred or consolidated with other entities.

Metal Fabrication: The construction of machines and structures from various raw materials. **Mold Inspection:** The certified inspection of an indoor environment for mold contamination. **Mold Remediation:** The process of removal and/or cleanup of mold from an indoor environment.

Mortgage Loans: Facilitate in the obtaining of a loan secured by real property.

Moss Removal: A service that uses a cleaning treatment process to remove dirt, debris and moss from affected areas of roofs, patios, decks and lawns. Treatments are designed to eat away at the moss/algae.

Motorcycle Mechanic: A small engine mechanic who specialized in maintaining and repairing traditional and nontraditional motorcycles, scooters, dirt bikes, and mopeds.

Moving and Storage: Help people and businesses relocate their goods from one place to another and provide storage facilities when needed.

Music: Provide live music entertainment.

Music Instructor: Someone who teaches music.

Nail Art: Creative ways to paint, decorate, enhance, and embellish the nails.

Nail Care: Clean and shape customers' fingernails and toenails. Polish and decorate nails.

Neurofeedback Training: Clinical treatment of Neurological/Learning disorders with electronic biofeedback devices.

Non-Profit: Organization that supports or engages in activities of public or private interest without any commercial or monetary profit.

Notary Public: A public officer who administers oaths and statutory declarations, witnesses and authenticates documents

Notary Public Mobile: A public officer who travels to a client's location to administer oaths and statutory declarations, witnesses and authenticates documents.

Nursery: Sell stock of landscape trees, shrubs and plants.

Nursing Home: A place of residence for people who require constant nursing care and have significant deficiencies with activities of daily living.

Nursing Services: Health care focused on the care of individuals and families.

Nutritionist: Health specialist in food and nutritional science.

Office Equipment: Sell or lease and repair office equipment.

Office Fragrancing: Provide a uniform and constant scent distribution in the office environment.

Office Furniture: Sell or lease office furniture.

Office Leasing: Lease or arrange leasing of office space.

Office Supplies: Sell general office supplies to companies.

Office Water Services: Provide water purification systems for business offices.

Oil and Gas Development: Sell the mineral rights underground to investors. Exploit, mine, and/or produce any or all minerals they own.

Ophthalmologist: Diagnose and treat all types of eye disorders. Has Doctor of Medicine degree.

Optician: A person who makes or sells eyeglasses and contact lenses in accordance with the prescriptions of ophthalmologists and optometrists.

Optometrist: Diagnose, manage, and treat conditions and diseases of the human eye and visual system.

Oral Surgeon: Dental specialists trained to treat and diagnose defects, injuries and diseases of the mouth, jaw, teeth, neck, gums and other soft tissues of the head.

Organic Garden Supplies: Offers organic gardening products (including worms), may demonstrate the methods or applications (for worm farming and composting), but they do not do the actual work for others (no gardening or landscaping).

Organizer: Assist clients to determine what to do with their items that are in a disorganized, cluttered state and help efficiently arrange the items and create systems to maximize the utility and visual appeal and allow easy retrieval.

Ornamental Iron Welding: Join iron by melting the pieces and adding filler that cools to become a strong joint used to create pieces for decoration.

Orthodontist: Examine, diagnose and treat dental malocclusions and oral cavity anomalies. Design and fabricate appliances to realign teeth and jaws for producing and maintaining normal function and for improving appearance.

Osteopathy Medicine (Canada Only): Applies the knowledge of the structure (anatomy) and function (physiology) of the body, to all diseases, disorders and dysfunctions. Osteopathic manual practitioners use their hands and provide a gentle "manual" approach, consistent with the osteopathic philosophy, to identify the causative factor of the problem and restore order to all of the systems: musculoskeletal, respiratory, cardiovascular, digestive, reproductive, or nervous system.

Packaging Shipping: Provide packaging and shipping of items for personal or business purposes.

Pageant Consultant: Specializing in the preparation of contestants for pageant competitions. **Paper Supplies:** Supply paper products to clients.

Paralegal: Assist lawyers by researching precedents, investigating facts, or preparing legal documents to support a legal proceeding, to formulate a defense, or to initiate legal action. **Parking Lot Maintenance**: Sweeping and maintenance of commercial properties.

Party Supplies: Sell items for use at a special event, such as service ware and decorations. **Patio Furniture:** Sell outdoor furniture such as chairs, tables, settees or loungers, suited for outdoor use.

Payroll Service: Compute wages, post wage data to payroll records, and issue payroll. **Pedodontics:** A branch of dentistry dealing with children from birth through adolescence. with a special importance in preventing tooth decay.

Periodontist: A specialty of dentistry that studies supporting structures of teeth, diseases and conditions that affect them.

Personal Assistant: Provide service by assisting another with their daily obligations, including administrative tasks and errands.

Personal Shopper: Provide service by assisting another with their shopping needs.

Personal Trainer: Plan and direct physical conditioning program for individuals.

Pest Control: Spray or release chemical solutions or toxic gases and set traps to kill pests and vermin such as mice, termites, and roaches that infest buildings and surrounding areas.

Pet Boarding: a place where animals are housed and maintained temporarily for a fee.

Pet Crematory: Cremates household pets and sells urns related to the cremation of a pet. **Pet Food:** Sell food for pets.

Pet Food Delivery: Deliver pet food to client's home.

Pet Grooming: Provide service to clean, brush and groom pets.

Pet Shop: Own and/or manage a pet shop.

Pet Sitter: Contracted service provider who takes care of a pet in its own home.

Pet Trainer: Provide behavioral training for pets.

Pet Waste Removal: Remove pet waste from client's home.

Pharmacy: Compound and dispense medicines, following prescriptions issued by physicians, dentists or other authorized medical practitioners.

Photo and Image Transfer: Transfer client's audio, video, and image files to digital format. **Photo Booths:** are designed to blend in and compliment your event providing hours of unlimited photos and creating fun memories that will last forever. Guest will enjoy the silly hats, oversized glasses, and many other fun wearing props.

Photo Supplies: Own/manage store that sells photographic supplies.

Photographer: Photograph persons, subjects, merchandise, or other commercial products. Develop negatives and produce finished prints.

Physical Therapist: Assess, plan, organize and participate in rehabilitation programs that improve mobility, relieve pain, increase strength, and decrease or prevent deformity of patients suffering from disease or injury.

Physician: Engage in general medicine practice.

Physician Assistant: A healthcare professional licensed to practice medicine with supervision of a licensed physician.

Physician Internal Medicine: Physician specializing in the diagnosis, management and nonsurgical treatment of unusual or serious diseases.

Physician Naturopathic: Physician specializing in complementary and alternative medicine emphasizing the body's intrinsic ability to heal and maintain itself, often using natural remedies such as herbs and foods rather than surgery or synthetic drugs.

Physician Pain Management: Physician specializing in the medical discipline concerned with the relief of pain.

Piano Service: Provide service for client's pianos including tuning and repair.

Picture Framing: The process of adding a container to a picture and other memorabilia in order to enhance it, make it easier to display or to protect it.

Pilates Instructor: Instruct clients to practice the workout that focuses on stretching, strengthening, and balancing the body.

Pilot Instructor: Provide education and training for clients to obtain a pilot certificate. **Pizza Delivery:** Delivery pizzas to customers home.

Plants: Sell live plants.

Plastic Fabrication: The construction of plastic into packaging for retail displays, trade show displays, magazine racks, display stands, point of purchase and literature displays.

Plastic Surgeon: Medical doctor dealing with the repair, replacement, or reshaping of malformed, injured or lost parts of the body.

Podiatrist: Diagnose and treat foot disorders.

Pool Service: Maintain and treat swimming pools on a regular basis.

Point of Sale (POS) System: A computerized network operated by a main computer and linked to several checkout terminals.

Post OP Recovery Center: A facility that provides port-surgical aftercare, pain management and observation, which is provided by licensed nurses

Power Washing: Use high-pressure streams of water to clean outdoor surfaces.

Precious Metal and Diamond Advisor: Using wealth management tools in the area of gold bullion and diamonds to protect the client's wealth through creating long-term prosperity by buying and holding gold, silver and natural fancy diamonds.

Precious Metals Buyer: Buys gold, platinum, rhodium and silver, examines, weighs and pays cash to sellers.

Printer: Sell and produce printed materials on paper.

Printer Repair: Repair computer printers.

Private Investigator: Seek, examine and compile information for a client.

Private Jet Charters: Operate an aircraft on a charter basis; flights take place outside normal schedules, by a hiring arrangement with a particular customer.

Private Money Lending: Lending money to a company or individual by a private individual or organization.

Process Server: is the procedure by which a party to a lawsuit gives an appropriate notice of initial legal action to another party (such as a defendant), court, or administrative body in an

effort to exercise jurisdiction over that person so as to enable that person to respond to the proceeding before the court, body, or other tribunal.

Professional Employer Organization (PEO): Provides comprehensive HR solutions for small and mid-size businesses. Payroll, benefits, HR, tax administration, and regulatory compliance assistance are some of the many services.

Professional Interviewer: A person who interviews others to help them state and clarify their ideas, thoughts, memories, etc. The responses may be provided to the interviewee and/or audiences in a written, audio or video format.

Project Management: Planning, executing, controlling and closing the work of a team to achieve specific goals and meet specific success criteria at a specified time.

Property Management: Coordinate and oversee leasing or rental of commercial, industrial or residential condo or apartment complex properties.

Property Management Consultant: Setting up online and educating about leasing or rental of a commercial or residential home, condo or apartment complex properties. I.E. Airbnb.

Property Tax Grievance: A Formal complaint filed against a town's assessed value on a particular parcel of property based upon comparable sales.

Prosthesis: Provide apparel and artificial substitute for woman recovering from breast cancer, mastectomy or lumpectomy.

Protective Coatings: Provides an applicator for auto, home recreation and industrial, specializing in truck beds and industrial non-skid coatings.

Psychologist: Diagnose, treat and help prevent disorders of the mind.

Psychotherapist: Provide individual and group counseling or therapy. Assess and evaluate problems through case histories, interviews and observations.

Pub/Tavern: A place where libations are served and consumed on premises; may also provide occasional entertainment.

Public Adjusters: Work with homeowners to get a just settlement after natural disasters. **Public Relations:** Promote and manage communication between an organization and the public

to build, manage and sustain a positive image. **Publishing:** The stages of the development, acquisition, copyediting, graphic design, production, marketing and distribution of works dealing with information, including the electronic media.

Quiltmaker: A person that makes a type of bed cover, that consists of two fabric layers that surround a middle layer of batting, then finished off with a binding that seals the edges. The quilts can be used as bedding, wall hangings, table runners or a tablecloth.

Radio Station: Talk radio. Interview guests, read news flashes, announce song titles and artists.

Raft Rentals: Rental of rafts and kayaks for white water rafting.

Real Estate Appraiser: Appraise real estate property to determine its value for purchase, sale, investment, mortgage or loan purposes.

Real Estate Auction Representative: Represents all types of purchasers at real estate auctions.

Real Estate Commercial: Assist with the sale, purchase or leasing of commercial real estate. **Real Estate Education:** Educate students to learn to sell real estate as a profession or how to invest in real estate for profit.

Real Estate Investment: Assist with the purchase of real estate properties for investment purposes.

Real Estate Residential: Assist with the sale, purchase or leasing of residential property. **Real Estate Staging**: Prepare a private residence prior to going up for sale in the real estate marketplace focusing on improving a property to make it appeal to the largest number of buyers.

Recreational Vehicle: The sale or lease of Recreational Vehicles (RV's).

Recruiter: Recruit by searching for executives to fill high-level positions.

Recycled Rubber Mulch: Sells a recycled mulch product (normally from tires) for both landscape mulch and playground safety mulch.

Recycling: Process used materials into new products in order to prevent the waste of potentially useful materials.

Reflexologist: Engages in the practice of massaging, squeezing, or pushing on parts of the feet, or sometimes the hands and ears, with the goal of encouraging a beneficial effect on other parts of the body, or to improve general health.

Reiki: Helps remind the body, mind and spirit of a state of wellness. Both relaxing and energizing. A driving of intention to channel universal healing.

Research Services: Provide the service of researching information to produce new knowledge. **Residential Cleaning Services:** New category name replaced Janitorial Services Residential. Perform cleaning services required for residential properties.

Residential Fragrancing: Provide a uniform and constant scent distribution in the home environment.

Resort: Own or operate a place used for relaxation or recreation, attracting visitors for holidays or vacations.

Restaurant Casual Dining: Operate a casual dining restaurant.

Restaurant Fine Dining: Operate a fine dining restaurant.

Restoration Damage and Cleanup: Provide cleaning services and restore or repair-damaged areas.

Retail: The sale of goods or merchandise from a fixed location.

Retail Apparel: Own or manage a retail-clothing store.

Retail Athletic Footwear: Sells athletic footwear.

Retail Batteries: Sell and recycle batteries for every type of product.

Retail Beauty Supplies: A specialty retailer and distributor of professional products for skin, hair and nails including wigs.

Retail Bicycles: a small business specializing in bicycle sales, maintenance and parts. **Retail Book Store**: Sells new or used books.

Retail Candy Bouquet: Sell an arrangement of candy, cellophanes, chocolate and more to create an edible floral type arrangement.

Retail Caskets and Urns: Sells a variety of burial caskets and an extensive variety of urns. (Does not offer grief counseling, embalming, etc.)

Retail Cigar Lounge: Own or manage a store that sells cigars and fine tobacco products. A place where cigars are sold and consumed.

Retail Coffee: Sell coffee and coffee related products.

Retail Firearms and Supplies: Sells firearms, ammunition and accessories.

Retail Formal Wear: Sell or rent apparel for formal occasions.

Retail Frozen Desserts: Sell frozen desserts, i.e., pies, cakes, bananas, yogurt, etc.

Retail Frozen Meat: Sell frozen meat products.

Retail Furniture: Sell furnishings and accessories for the home.

Retail Golf: Sell golf equipment and accessories.

Retail Grocery: Provide food and other items to the public.

Retail Handbags: Sell handbags.

Retail Jewelry: Sell jewelry.

Retail Juice Bar: An establishment that primarily serves prepared juice beverages. **Retail Lingerie:** Lingerie for men and women available for purchase in a retail setting. **Retail Luxury Linens:** Sell top quality bedding and home linens.

Retail Mattress: Sells mattresses, box springs, footboards and headboards (excludes linens).

Retail Olive Oil: Produce and provide Olive Oil and Olive Oil related products to the public. **Retail Paint Store:** Sell paint, painting supplies, accessories and equipment.

Retail Photo Gifts: Sell personalized picture gifts including personalized photo blankets.

Retail Plumbing Fixtures: Sells decorative plumbing fixtures for kitchen and bathrooms such as sinks, toilets, faucets, showers, and tubs.

Retail Pool and Spas: Sells pools and spas, offers products and services to maintain them. **Retail Precast Concrete:** Manufacturer of architectural products including pavers, site furnishings, custom precast concrete, etc.

Retail Pretzels: Sells pretzels and pretzel related products.

Retail Self Defense: sells retail products for defending oneself, personal property and keeping the well-being of another from harm. Retail Shelving: Sell shelving units.

Retail Shelving: Provide in home needs and designs through construction and installation. Allowing for better access, improved storage and more organizational options for cabinets and pantries.

Retail Ski Shop: Sells ski and snowboard equipment and supplies.

Retail Specialty Footwear: Sell specialized footwear to address a variety of foot ailments. **Retail Specialty Items:** A small retail outlet that focuses on selling a particular product range and associated items.

Retail Trade Uniforms: Retail and wholesale provision of trade uniforms, consisting of shirts, pants shoes, scrubs, overalls, smocks, and any other clothing considered a uniform for the professional or trade industry.

Retirement Community: Own or manage housing for the retired elderly.

Roof Maintenance Cleaning: Perform roof, window and gutter cleaning.

Running Coach: An individual who specializes in (a) introducing non-runners to the sport, and (b) encourages, trains, and coaches existing runners, of all abilities, through structured training programs and analysis, in order to advance one's passion, ability, and desire to become a better runner.

RV Sales and Leasing: Sell and lease recreational vehicles.

Safety Apparel and Equipment: Sell personal protective equipment and industrial supplies. **Safety Consultant:** Instruct in and sell safety products.

Sales Training: Teach courses in the successful methods of business sales.

Salon: Location where clients receive haircuts, manicures, and facials.

Salt Cave Therapy: Salt Cave provides 100% natural, effective, risk-free Salt Therapy treatments. Visitors simply relax in a treatment room, where the healing micro-climate of a natural Himalayan Salt Cave is reproduced by proprietary technology that fills the room with salt dust.

Sandblasting: Shooting of sand or an aggregate at high pressure to remove paint, rust, rot on wood to revitalize structures, etc.

Sanitization Service: An environmentally friendly solution used to treat all interior surfaces to eliminate harmful microorganisms in the work, home and automobiles. Can be applied to any surface or high touch areas, hard, soft and fabrics.

Scrapbook: Supply ideas and products to enhance mementos for the process of scrapbooking.

Screen Printing: Provide screen-printing services for marketing items such as T-shirts and hats.

Screens: Install and repair window screens.

Search Engine Optimization: is the process to improve the quality or volume of traffic for information on the World Wide Web. The search results are usually presented in a list of results and are commonly called hits.

Sleep Consultant: Provides support and advise to an individual in order to help them recognize ways in which they can improve their overall sleep.

Small Engine Repair and Service: involves the maintenance and repair of low-power internal combustion engines (gasoline/petrol) or electric engines.

Smog Check: Provide the specified procedure for measuring pollutant emissions of engines. **Social Media Consultant:** Assist and advise clients about growing their business and creating marketing campaigns by utilizing social media platforms (such as Linkedln, Facebook, Twitter and blogs).

Social Media Marketing: Targeting techniques such as Facebook and Twitter, social media advertising will reach your target audience no matter who and where they are.

Social Media Photo Printer: Company provides a Social Media Photo Printer Product and Service for businesses to use in conjunction with any marketing and advertising techniques. **Social Worker:** Degreed professional working for social justice on a variety of levels with the goal to improve the lives of people, groups, and societies.

Software Development: Create custom application computer software for businesses and individuals.

Solar Energy Systems: Design and install solar power systems, which provides a renewable energy.

Speech & Dictation Instructor: Teaches the understanding of spoken words and expressive language through speech and dictation. Expressing ones self through spoken word, pitch, fluency and volume and being able to

reproduce in writing, words uttered by another.

Speech Pathologists: address people's speech production, vocal production, swallowing difficulties and language needs through speech therapy in a variety of different contexts including schools, hospitals, and through private practice.

Spiritual Medium: One who communicates with spirits to facilitate communication between non-mediumistic people and spirits who may have messages to share.

Sporting Goods: Supply equipment and clothing used in sports such as archery, camping, hockey, skiing, softball, fishing, etc.

"Does not make recommendations on investments." **Thrift Store**: retail store run by a charitable organization to sell mainly used goods donated by members of the public, and are often staffed by volunteers

Ticket Broker: Sell tickets to any event for market value.

Tile and Marble Sales: Sell tile and marble for home or business.

Title Insurance: Insurance to protect an owner's or lenders financial interest in real property against loss due to title defects, liens or other matters.

Towing Service: Provide service to tow or haul a vehicle or trailer.

Toxic Compounds Removal: The removal of physical toxicants which can ultimately be fatal if inhaled such as asbestos, toxic molds, lead paint, and some building materials.

Toxic Compounds Testing: Uses specialized equipment to test and examine the physical toxicants in asbestos, toxic molds, lead paint, and some building materials.

Voice Talent: Provides spoken talent for a variety of projects including radio and TV commercials, video games, telephone hold systems and other areas where a professional vocal talent is preferred.
